This order is liable to be withdrawn by the prescribed authority if it is subsequently found that the activities of the applicant are not genuine or if they are not carried out in accordance with all or any of the conditions subject to which it is granted, if it is found that the applicant has obtained the provisional approval by fraud or misrepresentation of facts or it is found that the assessee has violated any condition prescribed in the Income Tax Act, 1961.

If at any time registration granted under section 12AB or approval granted under sub-section (23C) of section 10, is cancelled by the prescribed authority for specified violations as mentioned in sub-section (4) of section 12AB or under 15th proviso to sub-section (23C) of section 10, then approval under subsection (5) of section 80G shall be deemed to be withdrawn.</p> <p>b. If, at any point of time, it is noticed that Form No. 10A has not been duly filled in by not providing, fully or partly, or by providing false or incorrect information or documents required to be provided under sub-rules (1) or (2) of rule 11AA or by not complying with the requirements of sub-rules (3) or (4) of the said rule, the Principal Commissioner or Commissioner, as referred to in sub-rule (5) of the said rule, after giving an opportunity of being heard, may cancel the approval granted in Form No. 10AC and Unique Registration Number(URN) issued under sub-rule (5) of the said rule, and such approval in Form No.10AC or such Unique Registration Number (URN) shall be deemed to have never been granted or issued.</p>
	<p>Other violations</p> <p>a. The institution or fund shall apply for approval within 6 months of commencement of the activities or at least 6 months prior to the expiry of period of provisional approval, whichever is earlier.</p>
